1. About this document

1.1 Function

This operating instructions manual provides all the information you need for the mounting, set-up and commissioning to ensure the safe operation and disassembly of the safety switchgear. the operating instructions must be available in a legible condition and a complete version in the vicinity of the device.

1.2 Target group: authorised qualified personnel

All operations described in this operating instructions manual must be carried out by trained specialist personnel, authorised by the plant operator only.

Please make sure that you have read and understood these operating instructions and that you know all applicable legislations regarding occupational safety and accident prevention prior to installation and putting the component into operation.

The machine builder must carefully select the harmonised standards to be complied with as well as other technical specifications for the selection, mounting and integration of the components.

Only if the information described in this operating instructions manual are realised correctly, the safety function and therefore the compliance with the Machinery Directive is maintained.

2.2 Special versions

For special versions, which are not listed in the order code below 2.1, these specifications apply accordingly, provided that they correspond to the standard version.

2.3 Purpose

The safety switch has been designed to prevent, in conjunction with the control part of a machine, movable safety guards from being opened before hazardous conditions have been eliminated. They are also suitable for fitting on profile sections and existing equipment.



Safety switches can only be used for applications, in which the hazardous situation is terminated without delay (e.g. runon movements) when the safety guard is opened.

When the safety guard is opened, the NC contacts are positively opened and the NO contacts are closed.

The user must evaluate and design the safety chain in accordance with the relevant standards and on the required safety level.

3. Mounting

3.1 General mounting instructions

3/2 mounting holes are provided for fixing the switch. The safety switch must not be used as end stop. Any mounting position. The mounting position however must be chosen so that the components are protected against soiling and damage. In case of painting activities, the components must be covered. The supplied fixing material must be used. If another actuating direction is desired, the four screws of the actuating head must be loosened. Turn the actuating head in the desired direction and retighten the screws (tightening torque 0.5 Nm). The default screws installed in the actuating head can be replaced with the supplied tamperproof screws.




The 3-pole variants can only be connected to 2 screw points. For stability reasons, at least the hatched area shown on the image must be provided as full contact surface.





4. Rear side Electrical connection

4.1 General information for electrical connection



The electrical connection may only be carried out by authorised personnel in a de-energised condition.

The contact labelling can be found in the wiring compartment of the switch. For the cable entry, only suitable plastic cable glands with an appropriate degree of protection must be used. After wiring, dust and soiling must be removed from the wiring compartment. The safety switch is double insulated. The use of a protective ground connector therefore is not authorised.

5. Set-up and maintenance

5.1 Functional testing

The safety function of the safety components must be tested. The following conditions must be previously checked and met:

1. Check the free movement of the actuating element.

- 2. Check the integrity of the cable entry and connections.
- 3. Check the switch enclosure for damage.

5.2 Maintenance

A regular visual inspection and functional test, including the following steps, is recommended:

- 1. Check the free movement of the actuating element.
- 2. Remove particles of dust and soiling.
- 3. Check cable entry and connections.

Damaged or defective components must be replaced.

6. Disassembly and disposal

6.1 Disassembly

The safety switchgear must be disassembled in a de-energised condition only.

6.2 Disposal

The safety switchgear must be disposed of in an appropriate manner in accordance with the national prescriptions and legislations.








Straight actuator TZ/CO




Flexible actuator TZ/COF/HIS.1




Shortened straight actuator TZ/CK




Flexible actuator TZ/COF/HIS.2




Shortened angled actuator TZ/CWK





Straight radius actuator TZ/COR
