# 1. About this document

#### 1.1 Function

This operating instructions manual provides all the information required for the mounting, set-up and commissioning to ensure the safe operation and disassembly of the switchgear. The operating instructions must be available in a legible condition and a complete version in the vicinity of the device.

#### 1.2 Target group: authorised qualified personnel

The Schmersal range of products is not intended for private consumers.

All operations described in this operating instructions manual must be carried out by trained specialist personnel, authorised by the plant operator only.

#### 2.3 Purpose and use

The magnetic reed switches BN 20 with two contacts are designed to monitor the position of movable safety guards according to EN ISO 14119.



The magnetic reed switches are classified according to EN ISO 14119 as uncoded type 3 switchgear.

Only the listed magnets may be used for actuation of the magnetic reed switch. Only these magnets can guarantee flawless function and repeat

With suitable evaluation and concealed installation, the requirements for safety applications up to PL e in accordance with EN ISO 13849-1 can be satisfied.

# 3. UL notice (does not apply to-ST)



Field wiring terminals: Use Solid or Stranded, AWG 20-24.

Temperature rating of wire insulation: min. 75 °C

Caution! The grounding screw is not suitable for cULus applications. Attention! Pour les applications cULus, l'utilisation de la vis de mise à la terre dans

le produit n'est pas autorisée. Screw on Enclosure, 0.6 Nm or 5.3 Inch pounds.

Terminal Screw, 0.5 Nm or 4.2 Inch pounds

Use cable gland and sealing plug with a rating of Type 4 or better.

# 4. Mounting

### 4.1 General mounting instructions



When mounting to protective equipment, the requirements of standard EN ISO 14119 must be taken into account.


Two elongated holes are available for fastening the enclosure. Any mounting position, provided that the active surfaces are opposite. Keep away from metal chips.

Magnetic reed switches and actuators

- Do not use as limit stops.
- · Do not install in strong magnetic fields.
- · Do not install on ferromagnetic material.
- · Do not expose to strong vibrations or shocks.
- · Inseparably fix to the safety guard.

# 5. Electrical connection

#### 5.1 General information for electrical connection



The electrical connection may only be carried out by authorised personnel in a de-energised condition.

The contact labelling can be found in the wiring compartment of the switch.

#### Settle length x of the conductor: 6 mm






Cable glands (included in delivery) are only authorised for permanent cables. The constructor must provide for the necessary strain relief. After wiring, dust and soiling must be removed from the wiring compartment.


1 NC contact BN 20-01Z with actuating magnet BP 20






In version -10 and -01: When the switches and actuators come together, the colours must coincide: Red (S) to red (S) and green (N) to green (N).

1 bistable contact BN 20-RZ with actuating magnet BP 20S




#### **BN 20-2RZ-ST**

# 6. Maintenance

- · Remove particles of dust and soiling.
- Check that the cable glands are fitted in accordance with the applicable operating instructions manual



Do not open the device when live.

Damaged or defective components must be replaced.

# 7.1 Disassembly

The switch must be disassembled in a de-energised condition only.

#### 7.2 Disposal

The switch must be disposed of in an appropriate manner in accordance with the national prescriptions and legislations.
